Homelessness	All parents will be given a Project Upstart Student Eligibility Questionnaire. If the questionnaire indicates that the family has unstable housing, the School Counselor will contact the parent to clarify their housing situation. The counselor will refer the family to Project Upstart and they will offer transportation services, and a referral to a homeless shelter facility.
Unfamiliar with School System	The Community Involvement Specialist will identify and assist parents of ELL students and parents of students new to the country with the registration process and will refer parents to social services available to them. She will act as a Liaison between teachers and parents and will provide translating services for parents.
